- Commissioner Cross stated that the insulation company sprayed insulation in the 2 inch gap located in the equipment room and the kitchen room; the gap was adversely affecting the HVAC during warm weather; next step is to test whether the gap is properly fixed so the company will smoke the area to see if there is any air movement; Paul Griffin, from CTA, contacted Commissioner Cross and stated that CTA will pay the contractor for the cost of the spray insulation, then CTA will submit the bill to the HFD for reimbursement
